**MOTION FOR EXTENSION OF TIME TO FILE RESPONSIVE PLEADING AND
REQUEST FOR EXPEDITED TREATMENT**

In accordance with Ohio Adm. Code 4901-1-12 and 4901-1-13, The East Ohio Gas Company d/b/a Dominion East Ohio (DEO or the Company) respectfully requests a five-day extension of time to file a responsive pleading in this case, which will cause the answer to become due March 14, 2016. Good cause exists to grant this motion, which is detailed below.

On February 16, 2016, the Complainant filed its complaint. The complaint involves numerous accounts and allegations dating back several years, some as far back as 2008, which has made the investigation of the complaint more difficult. Investigating the complaint's factual allegations has also required DEO to coordinate with various employees in different departments. Due to these factors, and despite the Company's best efforts, the investigation has not been completed in time to allow an answer to be filed on the due date of March 8, 2016. To allow DEO time to complete this factual investigation, conduct legal review, and draft the answer, DEO requests a five-day extension of the due date.

The Company represents that this request is not being made for the purposes of delay and requests expedited treatment of this motion in accordance with Ohio Adm. Code 4901-1-12(C).

For the foregoing reasons, DEO respectfully requests that the Commission grant its request for a five-day extension of time to file a responsive pleading, on an expedited basis.
