In past years DP&L has proven that they are not a well run, efficient operation. They have been proven to over pay their executives, purchase fine art with revenue dollars and allow wasteful and inefficient work practices among their hourly employees to flourish. This year alone, I have found DP&L contractors parking their truck behind my barn, without permission, when they should have been working.
