The utilities claim they are losing money on their aging plants, and now they're demanding that consumers cover the cost of their bad decisions not to invest in cheaper, cleaner power, like natural gas. Gee -- Isn't FirstEnergy the same utility whose lack of proper maintenance of their infrastructure caused the blackout of the Eastern Half of the U.S. in 2003 ? ?

FirstEnergy championed deregulation just seven years ago. It even threatened to sue the state if the State tried to re-regulate prices. But that was before shale gas became a more economical option. FirstEnergy's old coal and nuclear plants haven't been winning those wholesale auctions that gas-fired-plants now dominate. Our local union's partnership with American Electric Power Ohio (AEP Ohio) has ensured that these capital and maintenance projects have supported middle class jobs in the central Ohio region and throughout the state of Ohio.

New U.S. Environmental Protection Agency regulations and volatile commodity prices have forced or accelerated shutdown of many of Ohio's power generating plants. The Purchase Power Agreement (PPA) AEP Ohio has filed with the Public Utilities Commission of Ohio (PUCO) addresses these concerns by providing stable and predictable revenues for its generating plants.

The Columbus/Central Ohio Building Trades supports the PPA's goal of refueling and/or repowering existing plants as natural gas facilities over the next two decades. It is critical to keep these power generating facilities operating in Ohio, to ensure stable electrical service to Ohioans and to continue the significant economic impact these facilities have on the communities they are located in.

AEP Ohio's PPA also seeks to develop 900 megawatts of power generation through new wind and solar projects in Ohio.
