The Company respectfully requests that the Commission issue an updated certificate, if applicable, to reflect the Company’s name as “West Safety Communications Inc.” The Company is authorized to provide: facilities-based and resold competitive local exchange and interexchange services in Ohio pursuant to Certificate No. 90-9364 granted in Case No. 08-1289-TP-ACE.

The Company’s existing tariff title pages are attached hereto as Exhibit B and the replacement tariff title pages, with a proposed effective date of April 13, 2016, are attached hereto as Exhibit C. 
