Statement: Actual complaint dates back to when I resided at 2805 E. 125th upper level Cleveland, Ohio 44120 approximately sixteen years ago. As I was moving from the residence a Dominion East Ohio Gas Agent came to the residence to calculate the final meter read and misread about three-thousand dollars of charges on my final bill. I did contact Dominion East Ohio Gas Company about my concerns and did not receive agreeable results. The reason I brought this to the attention to PUCO today is to explain why my Dominion East Ohio Gas bill was approximately six-thousand dollars over the years in the first place.

I have been a Dominion East Ohio Gas customer for approximately twenty years. Today I am filing a complaint against Dominion East Ohio Gas company at my current address 12919 ShadyWay road Garfield Heights, Ohio 44125 for overpayments, being targeted as a joke by the Dominion East Ohio Gas Company Agents, prejudice and discriminated against, manipulated, lied too and Dominion violating government rules.

Continued Statement: On January 2, 2015 I was removed from the PIPP Plus Program because of missed payments from the months of December 2, 2014. On December 3, 2014 I made a one-time payment of one-hundred, three dollars toward my Dominion East Ohio Gas bill.

Unfortunately I made that payment prior to receiving current bill for December and was told the one-hundred, three dollar payment went toward my arrears and did not account for the PIPP Plus payment of one-hundred and twenty-two dollars due. Enclosed is a attached copy of the actual bill and payment receipt.

I did not make a payment for November 17, 2014 and have enclosed a copy of November of 2014 bill. No payment was made in the month of October 17, 2014. Two payments was made in September 3, 2014 in the amount of one-hundred and four dollars and September 25, 2014 in the amount of one-hundred dollars. I have enclosed two receipt copies and a copy of October bill reflecting these two payments and a copy of September bill.

At this time I am going to begin with providing copies of 2015 Dominion East Ohio Gas Company bills and payments. As stated above I was removed from the PIPP Plus Program January 2, 2015. I contacted a Dominion agent to discuss how I could have services restored and re-enrollment on the PIPP Plus Program.

After speaking with the Dominion agent I was informed I could pay the one-hundred and seventy-five dollars weatherization fee and was responsible for paying the past due PIPP Plus balance of two-hundred and seventy-nine dollars in order to become re-enrolled on PIPP Plus. Outlined in the PIPP Plus guidelines it is stated, "that I am responsible for paying actual bill amount for the month I was dis-enrolled". On the PUCO website regarding the weatherization fee it, states "I am responsible for paying the one-hundred and seventy-five dollars and a one- time arrears payment".

January 2, 2015 Dominion Gas actual current charges was one-hundred, fifty-two dollars and fifty-three cents a lesser amount from the one-hundred and seventy-five dollars. It is unfair to allow a customer to pay the current charge amount when they have already paid the one- time weatherization payment of one-hundred and seventy-five dollars. Enclosed is a copy of January 2, 2015 Dominion Gas bill and the payment receipt of one-hundred and seventy-five dollars paid on February 2, 2015.

February 2, 2015 I was billed two Dominion Gas bills, but I only received one in the mail. Normally after paying the one-hundred and seventy-five dollars weatherization fee I would have to pay the PIPP Plus arrears and current PIPP Plus payment the following month. Enclosed are copies of the February Dominion East Ohio Gas bills. Also after paying the one-hundred and seventy-five dollars I received a letter stating I was reenrolled back on PIPP Plus. Enclosed copy of the re-enrollment PIPP letter.

In March I contacted Dominion East Ohio Gas Company and spoke with a agent on the phone and asked her what I needed to pay to become re-enrolled on the PIPP Plus Program. At that time when I spoke with the Dominion agent I had not received March or the second February bill. The Dominion agent told me I had to pay two-hundred and seventy-nine dollars on or before March 20, 2015 to become re-enrolled on PIPP Plus.

I paid two-hundred and seventy-nine dollars on March 20, 2015. Enclosed are copies of April 2, 2015 Dominion East Ohio Gas Company bill that reflects this payment along with late fee charges and copy of on-time March 20, 2015 payment receipt.

After making the two-hundred and seventy-nine dollars PIPP Plus arrear payment I received another letter in the mail April 24, 2015 confirming my re-enrollment on PIPP Plus. Enclosed copy of the PIPP letter.

However the Dominion agent informed that I was not re-enrolled on PIPP Plus and I had to pay one-hundred, seventy-seventy dollars and forty-five cents before or on April 22, 2015. At this time I become frustrated and upset. On April 10, 2015 I proceed to go into the Council for Economic Opportunities in Greater Cleveland Heap/Housing Services Office located at 1849 Prospect Avenue Cleveland, Ohio 44115 to ask for assistance. I was unable to receive any financial assistance toward the Dominion gas bill because the deadline for help had expired. Instead the agent printed a hardcopy of Dominion East Ohio Gas Company request for the one-hundred, seventy-seventy dollars and forty-five cent payment. On April 22, 2015 I made a one-hundred, seventy-seventy dollars and forty-five cent payment to Dominion East Ohio Gas.

Enclosed are copies of the Council for Economic Opportunities print out of Dominion East Ohio Gas payment request, May 4, 2015 Dominion Gas bill that reflects the payment and a copy of the one-hundred, seventy-seventy dollars and forty-five cents payment receipt.

My gas usage for April 2, 2015 was lower in the amount of sixty-four dollars and eighty-seven cents, so therefore; I do not know where the Dominion East Ohio Gas agents are coming from with the payment amounts due.

May 4, 2015 I received my Dominion Gas bill and it is still reflecting that I owe two-hundred, eleven dollars and eighteen cents. I contacted the Dominion East Ohio Gas agent to discuss that I have already paid the one-hundred, seventy-seventy dollars and forty-five cent payment and did not understand where the new payment was coming from. No resolution was resolved from the phone call and I stopped calling Dominion East Ohio Company. I felt defeated, lied too, distrust worthy of Dominion, a joke, manipulated, discriminated against and prejudice against.

I continued to receive past due balances from Dominion East Ohio Gas Company. July 3, 2015 I made a one-hundred, twenty-two dollars payment. Enclosed is a copy of Dominion East Ohio Gas bill July 1, 2015, copy of August bill that reflects this payment and payment receipt.

At the end of September 2015 Dominion East Ohio Gas Company disconnected my services. I had to pay a total of two-hundred, seventy-two dollars and eighteen cents to restore services. Enclosed are copies of October 2, 2015 and November 2015 bills along receipt copies.

Today March 3, 2016 I am required to pay Dominion East Ohio Gas company one-hundred, sixty-three dollars and eighty-three cents by or on March 21, 2016 or my services will become disconnected. On February 19, 2016 I also made a payment of two-hundred, ninety-one dollars and forty-eight cents.

If granted a hearing I have copies of payment receipts.

At this time I am holding Dominion East Ohio Gas Company accountable for their actions by requesting for a formal hearing in order to receive compensation for my losses, compensation for being targeted as Dominion East Ohio Gas Company customer joke, compensation for being discriminated and prejudice against, compensation for being lied too, compensation for being manipulated, compensation for Dominion being a distrust worthy company and compensation for violating government rules.
