## MEMORANDUM IN SUPPORT

By Entry of October 3, 2012, the Commission authorized the temporary downgrade of the warning devices at the State Street grade crossing (DOT #473-711A) in Fremont, Sandusky County, Ohio, toward giving the interested parties requisite time to design and construct a new warning device installation, including interconnection with adjacent highway traffic signals.

Substantial progress has been made, as the parties are now fine-tuning the related design/engineering, with the expectation that in fairly short order the ORDC will approve same, and then request that the Commission issue a related construction order.

In the meantime, Norfolk Southern respectfully requests that the instant downgrade be extended, at this point for an additional twelve (12) months, so through April 3, 2017. Logistically, once the Commission issues the above-referenced construction order, presumably in a new case, the instant case could be dismissed and/or consolidated into the new case, with the understanding that the downgrade would be deemed authorized/approved pending construction of the new warning device installation.

The City and the ORDC have been advised of and consent to this request.
