
Notice of Second Amendment to Proposed Major Utility Facility

FACILITY DESCRIPTION

The Ohio Power Siting Board ("Board") issued a Certificate of Environmental Compatibility and Public Need on September 17, 2015 in Case No. 14-2322-EL-BGN authorizing Clean Energy Future-Lordstown, LLC to construct, own, and operate an 800 megawatt (MW) gas fired, combined cycle power station, Lordstown Energy Center, located on an industrially zoned site within the Lordstown Industrial Park. The project will consist of two gas fired, high efficiency combustion turbines with two heat recovery steam generators and a single steam turbine.

LOCATION AND GENERAL LAYOUT

The general location and planned project layout of Lordstown Energy Center is shown on the map below:

Clean Energy Future-Lordstown LLC has an has an Application for a Second Amendment of its Certificate of Environmental Compatibility pending before the Board for approval of changes associated with the temporary construction use of two additional adjacent parcels, plus construction of a stormwater conduit across for discharge to Mud Creek.
