## MEMORANDUM IN SUPPORT

NAPG hereby requests a thirty (30) day extension of its Certificate No.12-249G(2), pursuant to Admin. Code 4901:1-27-09. NAPG's certificate became effective on May 4, 2014, and expires on May 4, 2016.


Rule 4901:1-29-09(B) provides, in pertinent part:

Any renewal application filed fewer than thirty calendar days prior to the expiration date indicated on the certificate, but no later than the expiration date on the certificate, shall be filed with a motion requesting an extension of the certificate. If the motion is filed in conformance with rule 4901:1-27-07 of the Administrative Code, it shall be deemed automatically approved unless, within three business days of its filing, the commission or an attorney examiner appointed by the commission rules otherwise.

Under Admin. Code 4901:1-27-09, NAPG's Renewal Application was due to be filed no less than thirty (30) days prior to the expiration date indicated on its provider certificate, or April 4, 2016. NAPG has not yet filed its Renewal Application and requests the additional time in order to complete the preparation of its Renewal Application and supporting exhibits.

For the all of the foregoing reasons, North American Power and Gas, LLC respectfully requests that its Certificate No. 12-249G(2) be automatically extended for thirty (30) days, until June 3, 2016, as permitted in Rule 4901:1-27-09.
