

**PAULDING WIND FARM HI LLC'S LIST OF ISSUES TO BE PURSUED DURING
CROSS-EXAMINATION AT THE EVIDENTIARY HEARING**

Pursuant to the Administrative Law Judge's Entry of February 29, 2016, Applicant Paulding Wind Farm III LLC submits the following list of issues that the Applicant may seek cross-examination of the parties, including Staff. Specifically, the Applicant may seek cross-examination regarding Staff's recommendations, including its recommended conditions, contained in the April 4, 2016 Staff Report. These recommendations include, but are not limited to:

1. Recommended Condition #5 (complaint resolution procedure);
2. Recommended Condition #7 (changes to project layout after submittal of final engineering drawings);
3. Recommended Condition #8 (submittal of as-built specifications;
4. Recommended Condition #13 (minimizing damage to field tile systems and soils in agricultural areas);
5. Recommended Condition #14 (Phase I archaeological survey);
6. Recommended Condition #19 (time limits on construction activities); and
7. Recommended Condition #26 (Coordination with FAA and ODOT regarding pole heights and locations).
