The Commission finds:

- (1) Each of the above-captioned applications was filed in accordance with Ohio Adm.Code 4901:1-40-04(F), for certification as an Ohio renewable energy resource generating facility as defined in R.C. 4928.01.
- (2) In addition, Ohio Adm.Code 4901:1-40-04(F)(2), provides for automatic approval of an application for certification as an eligible Ohio renewable energy resource generating facility, unless the Commission suspends the application within sixty days. By attorney examiner entry, and pursuant to Ohio Adm.Code 4901:1-40-04(F)(2), each application was suspended from automatic approval for certification.
- (3) Each applicant has filed a notice to withdraw its application.
- (4) The Commission finds that, based on each applicant's request to withdraw its application, each of the above-captioned applications should be dismissed.




ORDERED, That each of the above-captioned applications be dismissed. It is, further,




