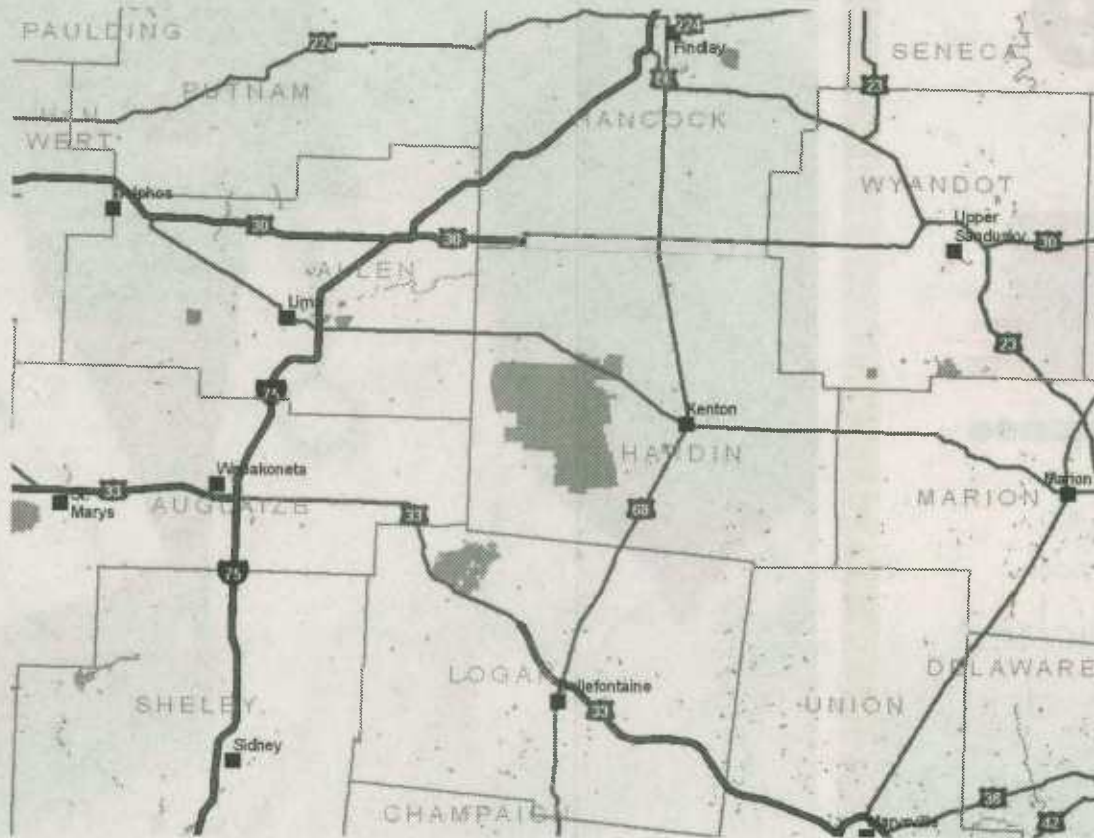
Notice of Third Amendment to Proposed Major Utility Facility (Wind Farm)

FACILITY DESCRIPTION

The Ohio Power Siting Board ("Board") issued a Certificate of Environmental Compatibility and Public Need in Case No. 09-479-EL-BGN on March 22, 2010 authorizing Hardin Wind Energy LLC, an affiliate of Invenergy Wind Development LLC to construct, own and operate up to a 300 megawatt wind farm consisting of up to 200 wind turbines at the Hardin Wind Farm in Hardin County, Ohio within portions of Lynn, Cessna, Marion, Roundhead, McDonald and Taylor Creek Townships, Hardin County, Ohio.

LOCATION AND GENERAL LAYOUT

The general location and planned project layout of the Hardin Wind Farm is shown on the map below.



AMENDMENT NOW PENDING

Hardin Wind Energy LLC has an Application for a Third Amendment of its Certificate of Environmental Compatibility pending before the Board for approval of additional wind turbine models, that could be selected for this project. A detailed description of the changes is available in the case docket.
