Licensee submits this letter as notice to the Public Utilities Commission of Ohio ("Commission") that effective March 23, 2016, Exelon Corporation ("Exelon") and Pepco Holdings Inc. ("Pepco Holdings") completed a merger transaction. The merger brings together Exelon's three electric and gas utilities - Baltimore Gas & Electric, Commonwealth Edison, and PECO Energy with Pepco Holdings' three electric and gas utilities - Atlantic City Electric, Delmarva Power and Pepco.

The transaction received regulatory approvals from the Federal Energy Regulatory Commission, the New Jersey Board of Public Utilities, the Delaware Public Service Commission, the District of Columbia Public Service Commission, the Maryland Public Service Commission, and the Virginia State Corporation Commission.
