MEMORANDUM IN SUPPORT

Staff requests that the Commission keep both the Report of the Commission's Consultant Regarding FirstEnergy's April 26, 2016 Standard Service Offer Auction and the Notification of SSO CBP Auction Results confidential and that they not be publicly released. This information identifies the details of various bids and parties making the bids in the April 26, 2016 FirstEnergy auction. This information is highly competitively sensitive. Public disclosure of this information would be highly prejudicial to the bidding parties and to the viability of any future auction in Ohio.
