

For all CT Residential telephone customers who are NOT currently under a monthly agreement, effective June 1, 2016, there will be a rate increase of \$1.25 per month on your TELEPHONE rates only as listed in the table below. *If you have an agreement, your rates will remain locked-in to what they currently are for the remainder of your agreement.* Many rural telephone companies, including CT, receive support from the Federal Universal Service Fund (FUSF). New rules reduce such support if a telephone company's local rates are below the national average. This increase is necessary to bring our residential local rates more in line with the national average & to avoid a reduction in our FUSF. If you have questions, please call 653-4000.
