**MEMORANDUM IN SUPPORT OF THE UNOPPOSED MOTION OF
THE DAYTON POWER AND LIGHT COMPANY
FOR EXTENSION OF TIME TO FILE REPLY MEMORANDUM
REGARDING DP&L'S MOTION TO IMPLEMENT THE SSR EXTENSION RIDER**

The Commission should grant DP&L a short 7-day extension of time, until May 13, 2106, to respond to the oppositions that were filed to DP&L's motion to implement the SSR-E, for two reasons. First, the oppositions are voluminous and address numerous technical issues. DP&L needs time to analyze the issues raised in the oppositions and to craft an appropriate reply. Second, the SSR-E would go into effect (if ever) on January 1, 2017. The 7-day extension of time thus would not interfere with the Commission's ability to decide DP&L's motion on a timely basis.

DP&L's motion is not opposed by the following parties which filed oppositions to DP&L's motion to implement the SSR-E: Industrial Energy Users-Ohio, The City of Dayton, Honda of American Mfg., Inc., the Kroger Co., Ohio Manufacturers' Association Energy Group, Ohio Partners for Affordable Energy, The Office of the Ohio Consumers' Counsel and the Ohio Energy Group.
