Please accept this Application as notification that Matrix Telecom, Inc. ("Matrix" or "Company") is changing the Company name to Matrix Telecom, LLC. Matrix was granted a Certificate of Public Convenience and Necessity to provide interexchange and local telecommunications services, Certificate Number 90-9309, pursuant to authority granted in Case Numbers 08-534-TP-ACN and 12-2340-TP-ACN.

On December 28, 2015, Matrix Telecom, Inc., a Texas corporation, underwent a statutory conversion to become Matrix Telecom, LLC, a Texas limited liability company. The conversion of the Company to a limited liability company was merely a change in its corporate form accomplished through the filing of a Certificate of Conversion in Texas and did not entail any merger or other transactions interrupting the existence of the Company. Included with this Application is a copy of the Registration as a Foreign Limited Liability Company issued by the Ohio Secretary of State.

The change in corporate form will be transparent to the customer and have no customer impact, as the name reflected in all customer communications (bills, notices, customer service, etc.) will remain "Matrix Telecom." Therefore, customer notice was not required.

The Company respectfully requests the Commission to change the Company's name to Matrix Telecom, LLC on all Commission records and issue an amended Certificate of Public Convenience and Necessity to reflect the Company's name as "Matrix Telecom, LLC."
