Dear Ms. McNeal:

The September 17, 2015, Opinion, Order, and Certificate ("Certificate") approving Clean Energy Future-Lordstown, LLC ("CEFL") Certificate of Environmental Compatibility and Public Need to Construct the Lordstown Energy Center established a set of conditions as part of the Certificate.

Within this set of conditions, **Condition No. 5** requires that:

**The Applicant shall conduct a preconstruction conference prior to the start of any construction activities. Staff, the Applicant, and representatives of the prime contractor and all subcontractors for the project shall attend the preconstruction conference. The conference shall include a presentation of the measures to be taken by the Applicant and contractors to ensure compliance with all conditions of the certificate, and discussion of the procedures for on-site investigations by Staff during construction. Prior to the conference, the Applicant shall provide a proposed conference agenda for Staff review. The Applicant may conduct separate preconstruction meetings for various stages of construction.**

Preconstruction meetings were held on:

- March 14, 2016 and March 24, 2016 for tree clearing. The conference agenda submitted to Staff on March 11, 2016 (Attachment A).
- April 1, 2016 for generating facility and civil construction. The conference agenda was submitted to Staff on March 30, 2016 (Attachment B); and
- April 28, 2016 for transmission line and switchyards. The agenda was submitted to Staff on April 26, 2016 (Attachment C).

Thus, this letter is to inform the OPSB Staff that CEFL is in compliance with **Condition No. 5** for the first three phases of construction.

- Power Plant and Laydown Area
- Located in Henn Parkway Industrial Park (show map)
- Approximately 33 acre area on south side of Henn Parkway
- Divided into the northern portion for the facility (~14 acres)
- Southern portion for the lay-down area (~19 acres)
- Tree Cutting Area (Siemens)
  - The tree area is approximately 5.5 acres in size, with scattered trees within that area
  - Tree cutting will occur in the permitted wetland areas
  - No cutting near Mud Creek
- Project Area (MJ Electric) [Mr. Erik Stenvig, M.J. Electric, LLC]
  - Two Switchyards (Interconnect (FE) and Collector (Plant) and Generator Lead Line (MJ Electric)
  - Located as shown on map, mostly north of Henn Parkway
- Tree Cutting Area (MJ Electric)
  - The tree area is approximately 11 acres in size, with scattered trees within that area
  - Tree cutting will occur in the permitted wetland areas
- Schedule (Siemens / MJ Electric)
  - Tree cutting deadline is March 31<sup>st</sup>.
  - Plan to mobilize immediately upon your authorization
  - Expect 1-2 weeks of work in the field for falling trees
