The filing is submitted on behalf of **tw telecom of ohio llc** (the “Company”) to notify the Commission that it has changed its name to Level 3 Telecom of Ohio, LLC. The Company respectfully requests that the Commission issue an updated certificate, if applicable, to reflect the Company’s name as “Level 3 Telecom of Ohio, LLC.” The Company is authorized to provide local exchange and interexchange services in Ohio pursuant to authority granted in Case No. 08-0591-TP-ACN, dated June 26, 2008, Certificate No. 90-9011.

The completed Public Utilities Commission of Ohio Telecommunications Filing Form is attached. A copy of the Company’s name change filing with the Ohio Secretary of State is attached hereto as Exhibit A. The Company’s existing tariff title pages and Check Sheets are attached hereto as Exhibit B and the replacement tariff title pages and Check Sheets, with a proposed effective date of June 4, 2016, are attached hereto as Exhibit C. A description of the proposed transaction is attached hereto as Exhibit D and a statement, regarding the name change, that appeared on the invoices of all tw telecom customers in the March bill cycle is attached as Exhibit E. The Company provides service to business customers only. The Company has changed its name to better align with their parent company, Level 3 Communications, LLC, under a unified brand and it will not affect any services or rates provided to customers of the Company.
