EXPEDITED RULING REQUESTED

Pursuant to Ohio Admin. Code § 4901-1-13(A), The Dayton Power and Light Company ("DP&L") requests a 7-day extension of time to file its Reply on its motion for a case management order to establish deadlines and to coordinate cases. With the 7-day extension, DP&L's filing deadline would be Monday, May 16, 2016.

This motion is not opposed by Ohio Environmental Council, the Environmental Defense Fund, the Environmental Law & Policy Center, the Electric Power Supply Association, and PJM Power Providers Group. The Office of the Ohio Consumers Counsel did not consent to the extension. DP&L did not receive responses regarding its request for an extension from the remaining parties that filed oppositions to DP&L's motion to establish deadlines and to coordinate cases.

**MEMORANDUM IN SUPPORT OF THE MOTION OF
THE DAYTON POWER AND LIGHT COMPANY
FOR EXTENSION OF TIME TO FILE REPLY MEMORANDUM
REGARDING DP&L'S MOTION FOR CASE MANAGEMENT ORDER
TO ESTABLISH DEADLINES AND TO COORDINATE CASES**

The Commission should grant DP&L a short 7-day extension of time, until May 16, 2106, to respond to the oppositions that were filed to DP&L's motion to implement the SSR-E, for two reasons. First, there have been a series of recent decisions by the Supreme Court of Ohio, the Supreme Court of the United States and the Federal Energy Regulatory Commission. DP&L needs time to analyze whether and how those decisions affect the ESP case and the appropriate schedule. Second, DP&L has been occupied this week preparing for and attending the Technical Conference.

This motion is not opposed by Ohio Environmental Council, the Environmental Defense Fund, the Environmental Law & Policy Center, the Electric Power Supply Association, and PJM Power Providers Group. The Office of the Ohio Consumers Counsel did not consent to the extension.
