Dear Examiner Parrot:

On behalf of Ohio Power Company (AEP Ohio) and the other Signatory Parties, on April 7, 2016, I filed a Stipulation and Recommendation (Stipulation) for the Commission's consideration in resolving this case. On April 20, 2016, testimony supporting the Stipulation was filed. Subsequently, the Company discovered an error in the bill impact estimate included with Andrea Moore's testimony. Enclosed are the updated schedules. The correction only changes the first page of the exhibit, as the year 1 bill impacts did not change and the typical bill calculations were based on the year one amounts. The reason for the change is a formula error in the spreadsheet that was not pulling the capital carrying charges for the VVO investment in years two through seven.
