ENTRY

{¶ 1} This Entry schedules for May 24, 2016, a continuation of the hearing held on February 24, 2016.

{¶ 2} By Entry issued February 19, 2015, the Commission established a procedural schedule that, among other things, scheduled a hearing for January 19, 2016.

{¶ 3} Pursuant to a November 5, 2015 motion to extend time, the attorney examiner issued, on November 24, 2015, an Entry rescheduling the hearing for February 24, 2016.

{¶ 4} On February 5, 2016, Staff and Eastern Natural Gas Company, Pike Natural Gas Company, and Southeastern Natural Gas Company (the Companies) filed a motion to

extend the deadline to file testimony and to potentially continue the February 24, 2016 hearing to a later date.

{¶ 5} By Entry issued February 8, 2016, the attorney examiner granted the parties' motion to extend the deadline to file testimony. Pursuant to the Entry, a hearing was held on February 24, 2016. Because issues remained to be resolved by the parties, the parties requested additional time to reach a stipulation.

{¶ 6} On April 22, 2016, the parties filed a stipulation that resolves all issues. By agreement of the parties, this matter will be heard on May 24, 2016. The hearing shall begin at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-C, Columbus, Ohio 43215-3793.

{¶ 7} It is, therefore,
