First Communications, LLC (“First”) submits to the Public Utilities Commission of Ohio (“Commission”) this notice of compliance with the Federal Communications Commission’s (“FCC”) *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 11-161,<sup>1</sup> *Second Order on Reconsideration* in Docket Nos. WC Docket No. 10-90, *et al.*, FCC 12-47,<sup>2</sup> Section 51.911(c) of the FCC’s rules, 47 C.F.R. §51.911(c), and the Commission’s May 4, 2016 *Entry* in the above-referenced proceeding.

First will comply with the above cited orders and rule by reducing its terminating intrastate end office rate elements to a combined \$0.0007 applicable to price-cap incumbent local exchange carriers in its operating territory pursuant Section 51.907 of the FCC’s rules, 47 C.F.R. §51.907. First adopts the corresponding incumbent local exchange carrier interstate terminating access rates as cited in its Ohio access tariff, P.U.C.O. Tariff No. 3, effective July 1, 2016.
