To Whom it may concern,

I am filing a formal complaint against Toledo Edison in regards to a bill I received for an apartifient own at 28155 Center St. Apt #6 Millbury, OH 43447. Although I assume but do not know for sure that an electricity agreement was contracted with the tenant of record namely a Sherri Ries who was the resident at that address for at least one year. Prior to moving in the electricity was not in my name. I have to assume the tenant paid the electrical bill for quite some time because to the best of my knowledge it was never interrupted. The unpaid bill is for the amount of \$404.66. Apparently the Edison failed to turn the power off upon her vacancy. Several months later I was billed for what was owed on this unit.

This apartment is one ten of a complex I own. For over 30 years I have not allowed the Edison to automatically switch over the power to my name without my expressed permission on a unit by unit basis. In this instance I did not give the Edison permission to turn the power over to my name even in cold weather. I have found it unnecessary the surrounding units on either side will provide enough heat to avoid having pipes freeze.

When I contacted the Edison about this erroneous bill I was told that I indeed did agree to an automatic turnover agreement. This is a completely false statement. I am confident the Edison will not be able to show one shred of evidence that I agreed to "automatic turn on". They further will not be able to show any examples of where I paid for an automatic billing in the last thirty years on any of the units of this apartment complex.

About every five years this purported agreement is attempted to be levied against me and proof of my agreeing to automatic turn on is never found because it does not exist.

This fact can easily be verified by requesting the Edison demonstrate proof that any electric bills in the last thirty years have ever been billed with "automatic turn on" for this apartment complex. Or on any of the other 40 units I own for that matter.

Listed are the following addresses of this complex: 28128 Center St. apt 1 & 2 / 28141 Center St. apt 3 & 4 / 28155 Center St. apt 5 thru 10.

Additionally my good name is being sullied and sanctioned with a poor credit rating because the bill was turned over to a collection company, LJ Ross, of which I am including a copy of.

I would greatly appreciate it if this matter could be looked into and resolved.
