Peerless Network of Ohio, LLC ("Peerless" or "Company") hereby submits this transmittal letter and revised tariff pages for Peerless's Ohio intrastate access tariff. These tariff revisions are being filed in accordance with the Commission's May 4, 2016 Entry in Docket No. 10-2387-TP-COI as well as the Federal Communications Commission's ("FCC's") *Report and Order and Further Notice of Proposed Rulemaking* in Docket Nos. WC Docket No. 10-90, *et al.* (FCC 11-161, rel. 11/18/11) and related orders, and Sections 51.911 and 61.26 of the FCC's rules. This submission includes:

These tariff revisions reduce the Company's terminating intrastate switched access rate elements to mirror the Company's corresponding interstate rates that will take effect in July 2016. The Company's interstate terminating end office switched access rate will be modified to reflect the lower rate required by the FCC to take effect in July 2016. This tariff filing also introduces a change to the rate structure for certain elements wherein a separate rate is established for originating and terminating access.
