REVIEW AND RECOMMENDATION

CASE HISTORY

Sol Systems, LLC, characterized as an authorized representative of Gary Krisher (Applicant), filed an application for certification of a renewable energy resource facility on April 8, 2011, in case no. 11-1925-EL-REN. The name of the facility is Krisher-Gary-OH-PV-2.55KW Residence, located at 5439 Townsend Road, Athens, OH, 45701. According to the application, the facility is a 2.55 kilowatt solar photovoltaic system. This roof-mounted system consists of 15 solar panels and was placed in-service in October 2008.

Under the Commission's sixty day auto approval process, the facility was certified effective June 8, 2011, and assigned the Ohio certification number of 11-SPV-OH-GATS-1391.

STAFF REVIEW

During a review of its records, Staff observed that the facility certified in case no. 11-1925-EL-REN appeared to be a duplicate of the facility certified in case no. 11-1098-EL-REN. Both cases pertain to a 2.55 kilowatt solar installation at the residence of Mr. Gary Krisher, located at 5439 Townsend Road, Athens, OH, 45701.

The application in case no. 11-1098-EL-REN was filed on March 4, 2011. It was certified with an effective date of May 4, 2011, and assigned the Ohio certification number of 11-SPV-OH-GATS-1077.

Staff contacted Sol Systems, the solar aggregator involved with the filing of the applications in these two cases, and Sol Systems confirmed the duplication by letter filed in each proceeding on April 30, 2014.

Staff reviewed the information on PJM EIS' Generation Attributes Tracking System (GATS) and confirmed that the facility certified in case 11-1925-EL-REN is not registered while 11-1098-EL-REN is registered. Therefore, with the facility registered only once on GATS, there has not been any double counting for this single solar facility.

STAFF RECOMMENDATION

Because the facility certified in case no. 11-1925-EL-REN is a duplicate of the facility certified in 11-1098-EL-REN, one of these certificates should be revoked. As the certificate granted in 11-1098-EL-REN is currently registered with GATS, Staff recommends that it be retained and that the certificate issued in case no. 11-1925-EL-REN be revoked.
