- {¶ 1} R.C. 4511.63 provides that, except where the Commission has granted an exemption, any bus, school vehicle, or vehicle transporting a material that is required to be placarded pursuant to 49 C.F.R. Parts 100-185 must stop before crossing at grade any railroad track. This section also provides that any local highway authority (LHA) may file an application with the Commission requesting approval of an exempt crossing.
- {¶ 2} On May 31, 2016, Patrick Ginnetti, Engineer for Mahoning County, the LHA, filed letters pursuant to R.C. 4511.63, requesting an exemption for school buses and motor vehicles carrying certain hazardous materials from stopping at the Palmyra

Road/County Road 136 (DOT#502481H) and South Duck Creek Road/County Road 53 (DOT#502475E) crossings in Mahoning County. Mr. Ginnetti noted that both roads are two lanes, with a speed limit of 40 miles per hour on Palmyra Road, and no posted speed limit on South Duck Creek Road. He added that the tracks have been paved over on both roads, and emphasized that exempting the crossing will reduce safety hazards for school buses and hazardous materials vehicles by eliminating the need to stop.

- {¶ 3} On June 13, 2016, Alan Hemphill, Chairman of the Jackson Township Trustees, the LHA, filed a letter pursuant to R.C. 4511.63, requesting an exemption for school buses and motor vehicles carrying certain hazardous materials from stopping at the Blott Road/Township Road 160 (DOT#544985Y) crossing in Mahoning County. Mr. Hemphill explained that Blott Road is two lanes, with a speed limit of 40 miles per hour, and contends that exempting the crossing would result in better safety for school buses and certain vehicles carrying hazardous materials, as the need to stop would be eliminated.
- {¶ 4} Accordingly, the attorney examiner finds that Staff should file a report of investigation regarding the requests by June 29, 2013.
- {¶ 5} Further, the attorney examiner finds that, in order for the public to have an opportunity to comment on the exemption requests, a local hearing should be scheduled. Accordingly, a public hearing on this matter should be held on Thursday, July 14, 2016, at 12:30 p.m. at the Jackson Township Hall, 10613 Mahoning Avenue, North Jackson, Ohio 44451-0400.
- {¶ 6} The secretary of the Commission should cause publication of the following legal notice in a newspaper of general circulation in Mahoning County, Ohio, one time, not less than seven days prior to the scheduled hearing:

The Public Utilities Commission of Ohio has scheduled a public hearing in Case Nos. 16-1216-RR-RCP, 16-1217-RR-RCP, 16-1365-RR-RCP regarding and requests exemptions for school buses and motor vehicles carrying certain hazardous materials from stopping at the Palmyra Road/County Road 136 (DOT#502481H), South Duck Creek Road/County Road 53 (DOT#502475E), Road/Township Road 160 (DOT#544985Y) grade crossings, which are located in Mahoning County, Ohio.

The purpose of the hearing will be to take public comment regarding the exemption requests. The hearing will be held on Thursday, July 14, 2016, at 12:30 p.m. at the Jackson Township Hall, 10613 Mahoning Avenue, North Jackson, Ohio 44451-0400. {¶ 7} Pursuant to R.C. 4511.63, the Commission shall authorize a limited period for the filing of comments by any interested person regarding the exemption request. Therefore, any interested person may file comments on the exemption request by June 29, 2016.
