MEMORANDUM IN SUPPORT OF OMAEG'S MOTION FOR LEAVE TO FILE TESTIMONY OUT-OF-TIME AND REQUEST FOR EXPEDITED RULING

OMEAG respectfully requests leave to file the direct testimony of Thomas N. Lause one day out-of-time. Extraordinary circumstances exist to grant such motion and given the brief delay in the filing no parties to this proceeding will be prejudiced as a result of the late filing.

On June 3, 2016, the Attorney Examiners issued an Entry scheduling a hearing regarding one rehearing issue, the Modified Rider RRS proposal submitted by the Ohio Edison Company, the Cleveland Electric Illuminating Company, and the Toledo Edison Company (the Companies) in their application for rehearing on May 2, 2016.¹ The Attorney Examiners also issued a procedural schedule, requiring that testimony on behalf of intervening parties be filed by June 22, 2016.²

In response to this Entry and expedited schedule, OMAEG worked diligently to seek out and engage expert witnesses for the rehearing and then to prepare expert witness testimony for submission by the June 22nd deadline. However, due to extraordinary business circumstances beyond the control of OMAEG and its counsel, the expert witness was unable to obtain the requisite management approval to file the direct testimony by the close of business yesterday. Management approval is necessary in light of concerns related to disclosing confidential and sensitive business information. Upon the receipt of management approval, counsel for OMAEG immediately filed the testimony with the Public Utilities Commission of Ohio (Commission) less than 24 hours after the deadline.

Given the brief delay, no parties will be prejudiced by this late filing. The filing of Mr. Lause's testimony less than 24 hours after the deadline, for good cause, will not unduly delay this proceeding or result in any harm or burden to the parties to this proceeding. Rather, not accepting this late filed testimony will prejudice OMAEG and other intervening parties to this proceeding as this testimony is critical to developing a full and complete record for the Commission's review of the Companies' Modified Rider RRS proposal on rehearing.

Motions for out-of-time filings are routinely granted by the Commission for good cause shown absent a showing of prejudice.³ Specifically, motions to file written testimony out-of-time that have demonstrated that other parties were not prejudiced by failure to timely file written testimony have been granted.⁴ In this case, not only has OMAEG demonstrated good cause for its late filing, no parties will be prejudiced by the brief delay in the filing.
