- {¶ 1} By Entry issued May 23, 2016, this matter was scheduled for hearing on July 25, 2016, with a procedural schedule that included expedited discovery and a June 28, 2016 deadline for intervenor testimony.
- {¶ 2} On June 27, 2016, Staff filed a motion for expedited treatment of its request to amend the procedural schedule and continue the hearing until October 11, 2016. Staff states that this extension is necessary because of scheduling conflicts and that all parties have consented to the revised schedule.
- {¶ 3} Ohio Adm.Code Chapter 4901:1-39 provides that the Commission establish a procedural schedule for energy efficiency and peak demand reduction program portfolio plans.
- $\{\P 4\}$ As all parties have agreed to Staff's request, the procedural schedule shall be amended as follows:
 - (a) June 28, 2016 to September 13, 2016 discovery response time reverts back to 20 days for all parties.
 - (b) September 13, 2016 Deadline for intervenor testimony.
