We are very familiar with operating in Choice territories and selling to residential and light commercial customers. We have the background and experience necessary to work with call centers to develop phone scripts and marketing material which will abide by the rules set forth by the Commission and Staff, maintain the integrity of the process and foster an environment of price transparency to the customer and all with more options than customers have had before.

NTherms's planned process for contracting with customers, providing contracted services, providing billing statements, and responding to customer inquiries and complaints will be in accordance with Commission rules adopted pursuant to Section 4929.22 of the Ohio Revised Code (http://codes.ohio.gov/orc/4929.22) and contained in Chapter 4901:01:1-27 (http://codes.ohio.gov/oac/4901%3A1-27) 4901:1-29 (http://codes.ohio.gov/oac/4901%3A1-29) of the Ohio Administrative Code.

nTherm, LLC Organizational Chart


