RESPONDENTS' MEMORANDUM CONTRA MOTION FOR DEFAULT JUDGMENT

Complainant Stand Energy Corporation ("Stand Energy") filed a Motion for Default Judgment in this case on June 13, 2016. Respondents Windstream Ohio, LLC, Windstream Nuvox Ohio, LLC and Windstream Communications, LLC (collectively, "Windstream") oppose that motion for the reasons set forth in this memorandum.

Windstream did not receive the service letter, which purportedly was sent on May 10, 2016, a copy of which is attached hereto as **Exhibit 1**. The address on that service letter is incomplete in that it did not include Windstream's statutory agent, CT Corporation System, and misspelled Cleveland. The delivery of the service letter may have failed. The Commission should not entertain a motion for default judgment when the respondent did not get served with the Complaint.

Moreover, the Commission is a creature of statute and it does not have the statutory authority to enter a default judgment. Stand Energy's motion relies on the Ohio Rules of Civil Procedure, which are not applicable to the Commission.

Windstream respectfully requests that Stand Energy's Motion for Default Judgment be denied. Windstream intends to file a motion for leave to file an Answer instanter after the 4th of July holiday weekend.


