- {¶ 1} R.C. 4511.63 provides that, except where the Commission has granted an exemption, any bus, school vehicle, or vehicle transporting a material that is required to be placarded pursuant to 49 C.F.R. Parts 100-185 must stop before crossing at grade any railroad track. This section also provides that any local highway authority (LHA) may file an application with the Commission requesting approval of an exempt crossing.
- {¶ 2} On July 11, 2016, a resolution approved by the Lucas County Commissioners was filed, requesting an exemption, pursuant to R.C. 4511.63, for school buses and motor vehicles carrying certain hazardous materials from stopping at the Toledo Lake Erie & Western Railroad (Blue Bird Line) crossings at Grand Rapids Road (CR# 1577), Ludwig Road (CR #1576), Jeffers Road (CR #111), Heller Road (CR #151), Box Road (CR #146), Hertzfeld Road (CR #221), and Neowash Road (CR #143) within Providence and Waterville Townships in Lucas County. The resolution indicates that the request is being made on behalf of the Otsego Local Schools as the Blue Bird Line tracks are no longer in use. The requested exemptions would reduce safety hazards for school buses and the public which are currently required to stop over 30 times per day at these crossings.
- {¶ 3} Accordingly, the attorney examiner finds that Staff should file a report of investigation regarding the request by July 21, 2016.

{¶ 4} Further, the attorney examiner finds that, in order for the public to have an opportunity to comment on the exemption requests, a local hearing should be scheduled for Thursday, July 21, 2016, at 1:30 p.m. at the Providence Township Hall, 13257 Perry Road, Grand Rapids, Ohio 43522.

{¶ 5} The secretary of the Commission should cause publication of the following legal notice in a newspaper of general circulation in Lucas County, Ohio, one time prior to the scheduled hearing:
