Application Description

AEP Ohio Transmission Company, Inc. proposes to relocate the Philo-Canton 138 (kilovolt) kV Transmission Line located in Guernsey County. The project consists of replacing one existing tower with four new poles on the existing Philo-Canton 138 kV transmission line at the West Cambridge distribution station. The new poles will be constructed entirely on AEP Ohio Transmission Company property and allow for future planned improvements to the West Cambridge distribution station. No new right-of-way is necessary for this project.

Site Description

The project is in Adams Township, Guernsey County at the West Cambridge distribution station. The construction of the four new poles will be located entirely on AEP Ohio Transmission's property.

Construction of the project would occur on previously disturbed land and would not result in any adverse ecological and cultural resources impacts. The project is not located within agricultural district land.

Recommended Findings

Staff's review of the application included consideration of the requirements listed in Ohio Revised Code Section 4906.10. Based on Staff's review, the application meets the necessary criteria for granting a certificate. Staff recommends that the Board approve the proposed certificate.
