The certification applications for AvidXchange (Case Numbers 16-1669-EL-AGG and 16-1670-GA-AGG) were received by the PUCO Docketing Division on August 1, 2016. However, the applications failed to meet requirements for Exhibit C-5 (forecasted financial statements for operations in Ohio during 2016, 2017 and 2018).

To comply with Exhibit C-5, you need to file forecasted income statements for 2016, 2017 and 2018 for the electric business that you expect to do (only) in Ohio. You also need to file forecasted income statements for 2016, 2017 and 2018 for the gas business that you expect to do (only) in Ohio. The electric and gas revisions need to be filed as separate documents. The minimum requirement for a simplified Income Statement needs to show Revenues, Expenses and Net Income due to your business in Ohio. Provide the years in column headings and label them. Provide annual rather than monthly data. Label each of the Exhibits as "Amended Exhibit C-5".

In order to avoid suspension and/or denial of your applications, please send the above referenced Exhibits to the PUCO Docketing Division with a note to include them as amendments to your application for Case Number 16-1669-EL-AGG and Case Number 16-1670-GA-AGG. You may use the same envelope for both cases if you file in paper form. The required amendments must be received by Tuesday, August 23, 2016 and comply with filing content requirements in order for staff to have sufficient time to review the information and for you to avoid suspension or denial of your applications.
