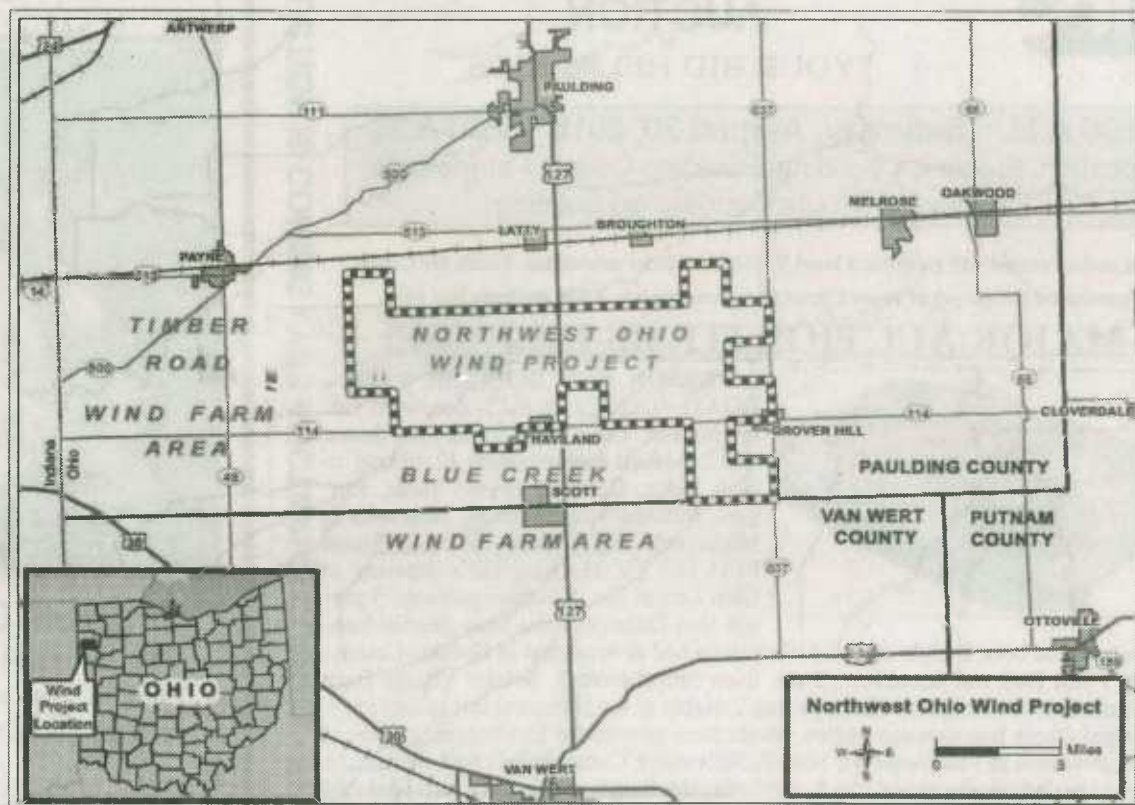
Notice of Second Amendment to Proposed Major Utility Facility (Wind Farm)

FACILITY DESCRIPTION

The Ohio Power Siting Board ("Board") issued a Certificate of Environmental Compatibility and Public Need in Case No. 13-197-EL-BGN on December 16, 2013 authorizing Northwest Ohio Wind Energy, LLC, now Trishe Wind Ohio, LLC whose sole owner is Starwood Energy Group Global, Inc. to construct, own and operate an up to 100 MW wind-powered electric generation facility consisting of up to 59 wind turbines at the "Northwest Ohio Wind Farm" within approximately 12,750 acres in portions of Blue Creek and Latty Townships, and the Village of Haviland, Paulding County, Ohio.

LOCATION AND GENERAL LAYOUT

The general location and planned project layout of the Northwest Ohio Wind Farm is shown on the map below.



AMENDMENT NOW PENDING

Trishe Wind Ohio, LLC has an Application for a Second Amendment of its Certificate of Environmental Compatibility pending before the Board for approval of additional wind turbine models, GE 2.3-116, Vestas V110-2.1 and Vestas 126-3.45 that could be selected for this project. A detailed description of the changes is available in the case docket.
