Natural Gas Service Agreement IT-4005 dated July 28, 2015 adding of a Delivery Point

Dear Ms. McNeal:

By its June 1, 2016 Finding and Order in Case No. 15-1997-PL-AEC, the Commission approved a Natural Gas Transmission Service Agreement with Village Energy Cooperative Association effective August 1, 2015. This Agreement contained one delivery point known as the Watson Farm Tap. I am writing today to notify the Commission that North Coast Gas Transmission, LLC and Village Energy Cooperative Association, Inc. have agreed to add one additional delivery point known as the "Ridgeview Farms Tap". No service terms are changing and all other terms and conditions in the previous approved agreement shall remain in full force and effect.


