{¶ 1} Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively, the Companies) are public utilities as defined in R.C. 4905.02 and, as such, are subject to the jurisdiction of this Commission.

{¶ 2} Pursuant to R.C. 4928.143(F), the Commission is required to evaluate the earnings of each electric utility's approved electric security plan (ESP) to determine whether the plan or offer produces significantly excessive earnings for the electric utility. On May 16, 2016, the Companies filed an application for the administration of the significantly excessive earnings test (SEET), as required by R.C. 4928.143(F) and Ohio Adm.Code 4901:1-35-10.

{¶ 3} On July 29, 2016, Staff and the Companies filed a stipulation and recommendation (stipulation) in this case.

{¶ 4} By Entry issued on August 29, 2016, the attorney examiner scheduled this matter for hearing to take place on September 14, 2016, in order to accomplish a review of the Companies' application and to consider the stipulation filed by the parties. However, due to a scheduling conflict, the attorney examiner finds that the evidentiary hearing should be rescheduled for September 29, 2016, at 11:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-D, Columbus, Ohio 43215-3793.

{¶ 5} It is, therefore,
