### MEMORANDUM IN SUPPORT

The Commission issued Certificate No. 14-868E(1), which certified Union Township as a competitive retail electric service provider to provide governmental aggregation services effective September 13, 2014. By its terms, the certificate is set to expire on September 13, 2016. Unfortunately, a renewal application to extend the effectiveness of the certificate will not be filed within the time period prescribed by Ohio Adm. Code 4901:1-24-09(A). Accordingly, additional time is needed to prepare the forthcoming renewal application and compile the supporting exhibits.

In order to afford Union Township the requisite time to prepare and file its forthcoming renewal application, Union Township respectfully requests an extension of its certificate. The extension should remain in effect for such time as the Commission deems necessary to perform its review of the forthcoming renewal application and avoid any break in the certificate. Granting an extension of the certificate would be in accord with Commission precedent and will not prejudice any party.<sup>1</sup>
