Pursuant to Rule 4906-3-03(B)(2) of the Ohio Administrative Code, Fred. Olsen Renewables USA LLC/Icebreaker Windpower, Inc. (Lake Erie Energy Development Corporation – Project Icebreaker) (Applicant) files notice that it has complied with the service requirement set forth in this rule. In accordance with this rule, a letter was sent to the property owners and entities affected by this facility notifying them of the September 28, 2016 information meeting. As required, service was sent by first class mail on September 6, 2016, at least 21 days before the meeting.

Further, the Applicant notes that the September 28, 2016 meeting is being held in conjunction with the U.S. Department of Energy, the U.S. Army Corps of Engineers, and the U.S. Coast Guard.
