{¶ 1} Duke Energy Ohio, Inc. (Duke or the Company) is a public utility as defined in R.C. 4905.02, and, as such, is subject to the jurisdiction of this Commission.

{¶ 2} On December 16, 2014, Duke filed an application requesting approval of tariff language regarding customer energy usage data (CEUD). Duke explains this application is being filed pursuant to Commission orders from Case No. 12-3151-EL-COI, which required Duke to submit an amended tariff specifying the terms, conditions, and charges associated with providing interval CEUD. In this application, Duke proposes to amend its tariff to provide details related to exactly what certified retail electric service (CRES) providers may request, how such data will be provided, and at what cost.

{¶ 3} By Entry on December 16, 2015, the Commission granted the motions to intervene by IGS Energy, Ohio Partners for Affordable Energy, Retail Energy Supply Association, Direct Energy Business, LLC and Direct Energy Services, , the Environmental Defense Fund, and Ohio Environmental Council.

{¶ 4} By Entry on July 26, 2016, the attorney examiner established a procedural schedule setting a hearing date for September 20, 2016. The attorney examiner also directed Duke to publish legal notice of the hearing in a newspaper of general circulation in each county in Duke's service territory.

{¶ 5} On August 12, 2016, the attorney examiner issued an Entry granting an August 8, 2016 joint motion for continuance. A hearing was scheduled for November 1,

2016. The attorney examiner again directed Duke to publish legal notice of the hearing in a newspaper of general circulation in each county in Duke's service territory.

{¶ 6} Thereafter, on September 9, 2016, Duke filed proof of publication of legal notice of the hearing originally scheduled for September 20, 2016. Duke's filing indicates that five of the six notices were published prior to the August 12, 2016 Entry continuing the hearing.

{¶ 7} Because legal notice of the September 20, 2016 hearing has already been published, the attorney examiner finds a hearing should be held on that date. Therefore, a hearing shall commence on September 20, 2016, 10:00 a.m., at the offices of the Commission, 180 E. Broad Street, 11th Floor, Hearing Room 11-A, Columbus, Ohio 43215-3793. The procedural schedule set forth in the August 12, 2015 Entry, however, will remain in effect.

{¶ 8} It is, therefore,

{¶ 9} ORDERED, That a hearing be held on September 20, 2016, in accordance with paragraph 7. It is, further,

{¶ 10} ORDERED, That a copy of this Entry be served upon all parties of record.
