**MEMORANDUM IN SUPPORT**

---

The Commission issued Certificate No. 14-868E(1), which certified Union Township as a competitive retail electric service provider to provide governmental aggregation services effective September 13, 2014. By its terms, the certificate was set to expire on September 13, 2016; however, on September 12, 2016, Union Township filed a motion to extend the certificate while it prepared the renewal application and compiled the supporting exhibits.<sup>2</sup>

In order to continue the effectiveness of Union Township's certificate and to provide adequate time for the Commission to review the renewal application, Union Township respectfully requests an extension of its certificate. The extension should remain in effect for such time as the Commission deems necessary to perform its review of the renewal application and avoid any break in the certificate. Granting an extension of the certificate would be in accord with Commission precedent and will not prejudice any party.<sup>3</sup>
