Staff Findings and Recommendations

I. Statutory Background

On December 4, 2013, the Public Utilities Commission of Ohio (PUCO) adopted amended rules for electric generator interconnection service and standards, in accordance with Ohio Revised Code (R.C.) 4928.06, R.C. 4928.11(A), as well as the State of Ohio's five-year rule review procedures. The amended rules, which are contained within Ohio Administrative Code (Ohio Adm.Code) 4901:1-22, subsequently became effective on July 10, 2014.

Specifically, R.C. 4928.11(A) provides:

For the protection of consumers in this state, the public utilities commission shall adopt rules under division (A) of section 4928.06 of the Revised Code that specify minimum service quality, safety, and reliability requirements for noncompetitive retail electric services supplied by an electric utility in this state, to the extent such authority is not preempted by federal law. The rules shall include prescriptive standards for inspection, maintenance, repair, and replacement of the transmission and distribution systems of electric utilities; shall apply to each substantial type of transmission or distribution equipment or facility; shall establish uniform interconnection standards to ensure transmission and distribution system safety and reliability and shall otherwise provide for high quality, safe, and reliable electric service; shall include standards for operation, reliability, and safety during periods of emergency and disaster; and shall include voltage standards for efficient operation of single-phase motors. The rules

regarding interconnection shall seek to prevent barriers to new technology and shall not make compliance unduly burdensome or expensive. When questions arise about specific equipment to meet interconnection standards, the commission shall initiate proceedings open to the public to solicit comments from all interested parties. Additionally, rules under this division shall include nondiscriminatory metering standards.

According to Ohio Adm.Code 4901:1-22-02(B), the interconnection service tariff filing requirement of each PUCO-regulated electric distribution utility (EDU) in the State of Ohio is as follows:

Ohio Adm.Code 4901:1-22-02(B), provides:

Each EDU in the state of Ohio shall file uniform interconnection service tariffs for commission review and approval pursuant to division (A) of section 4928.11 of the Revised Code that includes the procedures and technical requirements set forth in this chapter for interconnection service on a first-come, first-served basis.

The findings and recommendations in this document pertain to the interconnection service tariff (interconnection tariff) that has been filed by Ohio Power Company (Company), in response to the amended rules.

II. Company Filing Summarized

On September 12, 2014, Ohio Power Company filed an application to modify its interconnection tariff in Case No. 14-1609-EL-ATA. The Company included a red-line of its current tariff and a clean version of the proposed tariff in its filing.

On August 16, 2016, the Company filed a new application in Case No. 16-1730-EL-ATA, following discussions with PUCO Staff (Staff) about its September 12, 2014 tariff filing. The Company included a new red-line of its current tariff and a clean version of the revised tariff in this filing. The Company also filed a letter in Case No. 14-1609-EL-ATA to withdraw the initial application that is superseded by the new application, and requested that the case be dismissed.

On August 31, 2016, the Company filed an amended application in Case No. 16-1730-EL-ATA, with updates to its interconnection tariff for open access distribution service.

III. Filed Comments

No persons filed comments in this proceeding.

IV. Staff Findings

Following its review of Ohio Power Company's proposed interconnection tariff and any timely comments submitted in this proceeding, Staff makes the following findings:

- (1) Ohio Power Company is an EDU in Ohio, and therefore the Company had a tariff filing obligation in response to the amended Ohio Interconnection Services Rules.
- (2) The Company initially filed its proposed interconnection tariff on September 12, 2014. Following subsequent communications with Staff regarding the original filing, the Company filed a revised tariff on August 31, 2016.
- (3) Following a review of the revised tariff, Staff confirmed that the Company has satisfied its interconnection service tariff filing requirement.

V. Staff Recommendations

Following its review of the information submitted in this proceeding and other relevant data, Staff recommends the following:

- (1) Ohio Power Company has satisfied its interconnection service tariff filing requirement.
- (2) The Commission approve the Company's interconnection service tariff application, as filed on August 31, 2016.
