ENTRY

The Ohio Power Siting Board finds:

- (1) On December 16, 2013, the Ohio Power Siting Board (Board) approved an application filed by Northwest Ohio Wind Energy, LLC (Northwest) for a certificate to construct a wind-powered electric generating facility in Paulding County, Ohio. *In re Northwest Ohio Wind Energy, LLC*, Case No. 13-197-EL-BGN (*Northwest Certification Case*), Opinion, Order, and Certificate (Dec. 16, 2013).
- (2) On August 19, 2014, in the *Northwest Certification Case*, Trishe Wind Ohio, LLC (Trishe) filed an application to transfer Northwest's certificate to Trishe pursuant to an asset purchase agreement approved by the United States Bankruptcy Court for the District of Minnesota as Trishe had acquired Northwest's assets and permits. By Entry issued November 24, 2014, the Board acknowledged the bankruptcy court's order, approved the application, and authorized the transfer of Northwest's certificate to Trishe.
- (3) On February 18, 2016, Trishe filed the instant application regarding the certificate issued in the *Northwest Certification Case*, requesting authority to further upgrade the list of turbine models available for the project.
- (4) On May 10, 2016, Staff filed its Report of Investigation.
- (5) On August 5, 2016, Trishe filed a request to withdraw its application in this matter.
- (6) The Board finds that Trishe's request to withdraw this application should be granted, and this case should be dismissed and closed of record.


- (7) As a final matter, the Board notes that a motion to intervene in this matter was filed by the Ohio Farm Bureau Federation (OFBF). In light of the fact that this case is being dismissed, the Board finds that OFBF's motion is moot and no further action is necessary.

It is, therefore,


ORDERED, That this case be dismissed and closed of record. It is, further,

ORDERED, That a copy of this Entry be served upon all parties and interested persons of record.




