- {¶ 1} The hearing of Case No. 16-743-EL-POR is currently scheduled to begin on October 11, 2016. On September 29, 2016, Staff filed a motion for expedited treatment of its request to indefinitely continue the hearing to allow the parties more time to explore settlement of the issues in that proceeding.
- {¶ 2} In Case No. 16-574-EL-POR, Ohio Power Company had proposed a procedural schedule with hearings to begin on October 5, 2016, but no such schedule has been adopted at this time.
- {¶ 3} No hearings or procedural schedules have been established for Case Nos. 16-576-EL-POR or 16-649-EL-POR.
- {¶ 4} Ohio Adm.Code Chapter 4901:1-39 provides that the Commission establish a procedural schedule for energy efficiency and peak demand reduction program portfolio plans.
