1 Tuesday Evening Session,
2 September 27, 2016.

3 - - -

4 EXAMINER MCKENNEY: Let's go on the
5 record. Good evening. The Public Utilities
6 Commission of Ohio calls for hearing -- public
7 hearing at this time and place Case No. 16-395-EL-SSO
8 being In the Matter of the Application of The Dayton
9 Power and Light Company to Establish a Standard
10 Service Offer in the Form of an Electric Security
11 Plan.

12 As I mentioned previously, my name is
13 Bryce McKenney, and I'm an Attorney Examiner assigned
14 by the Commission to hear this case. Also with us
15 this evening is Commissioner Howard Petricoff, who is
16 sitting next to me here.

17 I'd like to thank everyone for coming
18 this evening.

19 At this time, I'd like to take the
20 appearances of the intervening parties that are here.
21 I'll start with the Company.

22 MR. FARUKI: Thank you, your Honor.
23 Charles Faruki from Faruki Ireland & Cox. I'm
24 Counsel of Record for The Dayton Power and Light
25 Company. With me also is my partner, Jeffrey

1 Sharkey. And also Michael Schuler, who is in-house
2 counsel with the Company, and on the papers as well.
3 Thank you.

4 EXAMINER MCKENNEY: Thank you.

5 Yes, sir.

6 MR. GARVER: Andrew Garver on behalf of
7 the Ohio Consumers' Counsel and DP&L's 455,000
8 residential utility customers.

9 EXAMINER MCKENNEY: Thank you.

10 MR. JACOBS: My name is Ellis Jacobs.
11 I'm an attorney at Advocates for Basic Legal
12 Equality, and I'm here on behalf of the Edgemont
13 Neighborhood Coalition.

14 EXAMINER MCKENNEY: Thank you,
15 Mr. Jacobs.

16 MR. JACOBS: Thank you.

17 MR. ADAMS: Greg Adams from the Utility
18 Workers Union of America, Local 175, out of Dayton,
19 Ohio. I represent the employees of DP&L.

20 EXAMINER MCKENNEY: Thank you.

21 As I mentioned briefly before, the
22 purpose of this evening's public hearing is to
23 receive comments from the public on the application
24 filed by The Dayton Power and Light Company. This is
25 not a question-and-answer session, but it is your

1 opportunity to let the Commission know what you think
2 about DP&L's application in this case.

3 The local public hearings are only one
4 aspect of the process. There will also be an
5 evidentiary hearing for the parties to present their
6 case to the Commission.

7 When you arrived, you were offered the
8 opportunity to sign up to testify. After I finish
9 with this introduction, I will begin calling the
10 witnesses forward that have signed up to testify and
11 ask you to come to the table and face the court
12 reporter.

13 The first name I have on this list is
14 Mary Sue Gmeiner.

15 Please raise your right hand.

16 (Witness sworn.)

17 EXAMINER MCKENNEY: You may proceed.

18 - - -

19 MARY SUE GMEINER

20 being first duly sworn, as prescribed by law,
21 testified as follows:

22 DIRECT TESTIMONY

23 MS. GMEINER: My name is Mary Sue
24 Gmeiner. I live on Arbor Avenue in Dayton. I was
25 here -- I came here originally to protest the

1 coal-bailout rider, which I understand now has been
2 withdrawn, so my remarks are a little more general.

3 But I would oppose any kind of coal
4 bailout or any support of -- any extra support of the
5 coal-fired power plants. And I would oppose this on
6 three levels.

7 One, at a personal level. I'm retired.
8 I'm on a fixed income. I'm already being as careful
9 as I can with my electricity use. And I also choose
10 the green energy option so that all of my electricity
11 is coming from solar, wind, geothermal, and I do that
12 in spite of any possible higher cost because I firmly
13 believe that climate change is real, it's here, and
14 we need to pay attention to it, and we need to move
15 away from fossil fuels as quickly as possible

16 At a second level really is at a national
17 level. And I would point out that the U.S. military
18 has determined that climate change is a serious
19 national security threat; they've made that clear.
20 And so, again, we need to turn away from coal, we
21 need to move away from coal and other fossil fuels as
22 quickly as possible.

23 And finally, on a moral level. We find
24 that coal is damaging our air; it's damaging our
25 water. And most importantly this impacts the poor

1 the most; those people who can't move away from the
 2 poor quality air and so on.

3 So as a member of a faith community, as a
 4 member of Ohio Interfaith Power and Light, I would
 5 encourage the PUCO to look at anything that can
 6 improve our use of renewable energy and move away
 7 from coal. Thank you.

8 EXAMINER MCKENNEY: Thank you.

9 The next name I have is Lynn Buffington.
 10 I'll ask you to just briefly raise your
 11 right hand.

12 (Witness sworn.)

13 EXAMINER MCKENNEY: Thank you.

14 - - -

15 LYNN BUFFINGTON

16 being first duly sworn, as prescribed by law,
 17 testified as follows:

18 DIRECT TESTIMONY

19 MS. BUFFINGTON: So my name is Lynn
 20 Buffington. I live in Beavercreek, Ohio. So the
 21 next county over, but still in the greater Dayton
 22 area.

23 And I'm here specifically because of
 24 coal, not fossil fuels in general, but coal. I'm
 25 concerned about the fact that we need to decrease our

1 use of coal, whether that slack is taken up by other
2 fossil fuels or other forms of energy such as
3 renewables. And so, therefore, I'm opposed to any --
4 whether you want to call it a bailout of coal, or
5 extra subsidy of coal, or rate hikes which therefore
6 enable older coal generating plants to stay open, I'm
7 just opposed to anything that helps us keep coal in
8 our mix of electricity sources.

9 And the reasons for that, the previous
10 person mentioned climate change; that's one of the
11 reasons. I want to say maybe a little bit more about
12 that. Some people think of climate change, they
13 think of tree huggers or environmentalists, and I
14 would like to mention that it goes way beyond that.

15 If you look at mainstream industries like
16 the property insurance industry or realtors, they
17 have been writing position papers and planning papers
18 about the impact of climate change on their
19 industries.

20 And so, coal is a -- for a certain amount
21 of energy, I'm sure most people know, to get a
22 certain amount of energy from coal contributes more
23 to climate change, to global warming, to carbon
24 dioxide gases than does another type of fossil fuel
25 to get that same amount of energy.

1 So there's big expenses. A vast majority
2 of us, whether we care about the habitat for a rare
3 species, the vast majority of Americans do care about
4 their property tax premiums and their property tax
5 deductibles and all these things are predicted to go
6 up because of climate change, and I'm sure that most
7 citizens would like them to go up less.

8 Another factor is the money that our
9 government needs to spend for natural disasters. An
10 example is Hurricane Sandy. We know climate change
11 did not cause Hurricane Sandy, but it made the
12 effects worse, it made the loss of property worse,
13 the suffering of people worse, because when you have
14 sea level that's higher, then any kind of storm surge
15 is much worse, it has a much bigger effect. So this
16 is something that all taxpayers pay for. And so, I'm
17 concerned about the impact of coal on the functioning
18 of our government and our government expenses.

19 And finally, the last thing I would
20 mention was mentioned previously is the health
21 effects of burning coal. My husband is a physician.
22 He's a pediatric specialist. He doesn't specifically
23 treat children because of their asthma, but asthma is
24 so on the rise these days that he treats plenty of
25 patients who do have asthma. And the particulates

1 that come from burning coal have a big impact on
 2 asthma, whether it's childhood or adult.

3 And so, just to summarize, we shouldn't
 4 be doing anything that helps us keep burning coal.
 5 Thank you.

6 EXAMINER MCKENNEY: Thank you.

7 Are you prepared? Would you like to
 8 testify?

9 MS. JEFFERS-TRACY: Yes.

10 EXAMINER MCKENNEY: Would you like a
 11 minute?

12 MS. JEFFERS-TRACY: No. I'm good.

13 EXAMINER MCKENNEY: Are you ready? Are
 14 you sure?

15 MS. JEFFERS-TRACY: Uh-huh.

16 EXAMINER MCKENNEY: Okay. I'll ask you
 17 to raise your right hand.

18 (Witness sworn.)

19 EXAMINER MCKENNEY: You may proceed.

20 MS. JEFFERS-TRACY: Sorry, I didn't read
 21 this first; I should have.

22 EXAMINER MCKENNEY: Would you like a
 23 minute? I know you just walked in.

24 MS. JEFFERS-TRACY: Yeah.

25 EXAMINER MCKENNEY: Okay. Let's go off

1 the record real quick. You can take a minute.

2 (Off the record.)

3 EXAMINER McKENNEY: We can go back on the
4 record.

5 Okay. You may proceed.

6 - - -

7 KAREN JEFFERS-TRACY

8 being first duly sworn, as prescribed by law,
9 testified as follows:

10 DIRECT TESTIMONY

11 MS. JEFFERS-TRACY: My name is Karen
12 Jeffers-Tracy. I'm from Fairborn. And I just wanted
13 to say that it's really important that we not put our
14 money and our investments in old infrastructure,
15 because we need a new way and we need to think about
16 the future. The future is not in old coal plants and
17 old ways of making energy. And even our energy usage
18 needs to change.

19 And I think if it's put before the
20 American people, they would be willing to change. I
21 think if it's put -- I mean, we accept the science of
22 climate change, and a lot of people are confused
23 about that, but if we stick with simply the science,
24 there's exaggeration on both sides, but science tells
25 us we need to change our way of life to use less

1 energy, and we need to change to renewable sources.

2 So I would be concerned that putting this
3 kind of money towards reviving old infrastructure
4 would not be -- would really not be fulfilling our
5 responsibilities for the future.

6 EXAMINER MCKENNEY: Thank you.

7 Thank you, everyone. That concludes the
8 list of names that I have to testify this evening.

9 Are there any questions that anyone else
10 has or is there anyone else who would like to testify
11 this evening?

12 (No response.)

13 EXAMINER MCKENNEY: I thank you all for
14 coming.

15 Mr. Commissioner, did you have any words
16 that you would like to make?

17 COMMISSIONER PETRICOFF: No, other than
18 to thank you all again for coming out this evening.

19 EXAMINER MCKENNEY: Thank you.

20 At this time, we are adjourned.

22 at 6:16 p.m.)
