## **ENTRY**

- $\{\P 1\}$  The Dayton Power and Light Company (DP&L) is a public utility as defined under R.C. 4905.02, and, as such, is subject to the jurisdiction of this Commission.
- {¶ 2} On February 22, 2016, DP&L filed an application for a standard service offer pursuant to R.C. 4928.141. DP&L's application is for an electric security plan (ESP) in accordance with R.C. 4928.143. Additionally, DP&L filed accompanying applications for approval of revised tariffs and for approval of certain accounting authority. In its application, DP&L asserts that the proposed ESP is designed to promote economic growth and stability in the state of Ohio.
- {¶ 3} By Entry issued on August 16, 2016, the attorney examiner adopted a procedural schedule in this matter. Thereafter, by Entry issued on October 4, 2016, the attorney examiner adopted a revised procedural schedule.

{¶ 4} On November 23, 2016, Staff filed a motion for continuance of the procedural schedule. Staff avers that more time is needed for further settlement discussions. Staff asserts that settlement discussions have been initiated and more time would allow the parties to fully explore the possibility of resolving these cases in whole or in part. Staff proposes that the hearing be continued until January 10, 2017.

- {¶ 5} The attorney examiner finds that Staff's motion to continue the procedural schedule in this case is reasonable and should be granted, in part. Accordingly, the prehearing conference in this case will be rescheduled for January 5, 2016, and the hearing for January 11, 2016, in Hearing Room 11-A, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, Columbus, Ohio 43215.
- {¶ 6} Additionally, on November 23, 2016, DP&L filed an unopposed motion for a seven-day extension of time to respond to IEU-Ohio's motion to dismiss. DP&L notes that IEU-Ohio has agreed to an extension of time for DP&L to respond to its motion to dismiss until December 6, 2016. Similarly, DP&L has agreed to an extension of time for IEU-Ohio to file its reply until December 13, 2016.
- {¶ 7} The attorney examiner finds that the unopposed motion for extensions of time to file a memorandum contra and reply is reasonable and should be adopted. Accordingly, any memoranda contra to IEU-Ohio's motion to dismiss shall be filed by December 6, 2016, and any replies by December 13, 2016.

- $\{\P\ 9\}$  ORDERED, That Staff's motion for a continuance be granted and the procedural schedule be established in accordance with Paragraph 5. It is, further,
