**REPLY COMMENTS OF
THE EAST OHIO GAS COMPANY D/B/A DOMINION EAST OHIO**

I. INTRODUCTION

In accordance with the Commission’s November 3, 2016 Entry in this case, The East Ohio Gas Company d/b/a Dominion East Ohio (DEO or the Company) files its reply comments to the rules and proposed revisions contained in Ohio Adm. Code Chapter 4901:5-25, concerning Gas Emergencies.

II. REPLY COMMENTS

A. Response to Vectren Comments

In its amended initial comments, Vectren Energy Delivery of Ohio, Inc. (Vectren) noted that in its operating experience, peak demand times typically occurred between the hours of four a.m. and nine p.m. (*See* Vectren Comments at 2.) Vectren recommended that Rule 4901:5-25-05(D) be amended to reflect these beginning and end times. (*Id.* at 2–3.)

DEO files these comments to note that its operating experience is consistent with Vectren’s regarding peak demand times. DEO supports Vectren’s recommendation to amend Rule 4901:5-25-05(D) to reflect a beginning time of four a.m. and an end time of nine p.m.

III. CONCLUSION

DEO appreciates the opportunity to comment on these rules. For the foregoing reasons, DEO respectfully requests that the Commission act in accordance with its comments.
