I am presently a paying on time customer of Dominion Gas Co. The first week in December, 2016 my furnace and hot water tank went out. I called Dominion Gas Co. and hours later they had to send out a service crew because the problem was found underground outside. The service explained to me they found water in my gas line outside, they blew the water out the line, and was able to light my furnace and water tank.

That lasted six days, and my furnace and water tank went out again, I called Dominion Gas and the once again hours later found the same problem with water in the lines outside and blew the water out the line and lit my furnace and water tank again, this time it only lasted four days. From that point on the problem continued every day and then hourly on Christmas Eve. I kept calling them back out 4-6 times a day.

It is a family tradition that all my grown children and grandchildren come to Cleveland on Christmas Eve and stay until the New year and that was ruined. I also have full custody of my ten year old special needs granddaughter who does not take well to change and being closed in is even worst. I need hot water daily and everyone deserves to have heat in 20-30 below zero weather. I have an electric stove that I used to boil water to bath, as well as keeping the back of the house warm.

I used a thick blanket to close off the front of the house, which caused negative behaviors in my special needs granddaughter. Dominion Gas (Sheila) Supervisor of emergencies told me they were not going to replace or repair my oven, which is now working when it wants too. She said I should not have been using it for heat. December 26, 2016 after I called P.U.C.O Dominion Gas, offered to put my daughter, granddaughter and myself up one night at the Embassy Suit Hotel, Only to have to return to a frozen house Dec 27, 2016 11:30am through 6:30pm.

The Supervisor of operations (George Smith) (216) 736-6946 entered my home 3pm December 27, 2016 to apologize and explain what was found, which was the very same line that Dominion Gas crew found the first week of Dec, 2016. Mr. Smith was as upset as me and witnessed the fight to keep my special needs granddaughter in the back of the house and just how cold it was in my home. Dominion Gas failed to provide us with heat and hot water throughout the whole month of December, 2016

The inadequate service I experienced for weeks, until I called P.U.C.O was not even fit for a dog.

I'm seeking a new stove or mines repaired and \$3,000.00 for all the suffering and aggravation I went through the whole month of Dec, 2016.

I also called Dominion 1/3/17, to get all the dates I called and how many times the service crew had to come out to my home, Oh! And now they don't have any records of problems at my address.

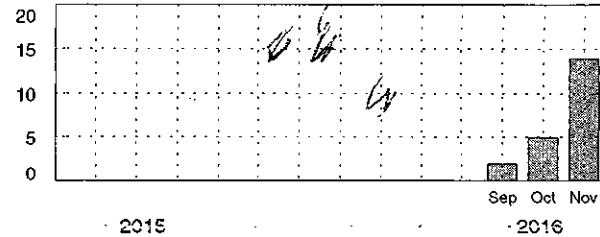
