
Guernsey Power Station, LLC Schedules January 25, 2017 Public Meeting to outline plans for 1,650 megawatt gas fired generation plant to be built in Valley Township, Guernsey County, Ohio.

Guernsey Power Station, LLC invites residents of Guernsey County, Ohio and other interested members of the public, to attend public informational meeting regarding company plans to build a 1,650 megawatt gas fired, combined cycle power station.

The electric generating facility will be located in Valley Township, Guernsey County off of Puritan Street. Seneca Lane, Interstate 77, Clay Pike Road, and a private rail line generally border the project area.

The project will consist of three gas fired, high efficiency combustion turbines, each using a gas and steam turbine with a heat recovery steam generator. It will use high efficiency air cooled technology. The plant will be served by natural gas from one or more pipelines. The generating station will be interconnected to a 745 kV transmission line located on the project property. Water and wastewater services will be supplied by the Village of Byesville. Construction of the project is estimated to begin in first quarter of 2018, with projected commercial operation to begin in third quarter 2020.

The public meeting will take place from 5:30 p.m. to 7:30 p.m., on Wednesday, January 25, 2017 in the cafeteria at the Meadowbrook High School, 58615 Marietta Road, Byesville, OH 43723. The meeting format will be similar to an open house and stations with information about the project presented on boards located throughout the room. Maps of the project area will be available to review. Company representatives will be near each station to answer questions. Those who attend the meeting may submit written comments that the applicant will summarize and include in its application.
