So, do we wait and see what Orwell does or switch now and then switch back in a month or two when & if they do takeover? This is

confusing and conflicting information that can prove very costly. What am I do? Wait until close to March 1st and see if Orwell takes over? I called them and they seem interested but what is the likelihood they can takeover by March 1st? I don't know and they can't tell me. I'm sure it's complicated. To switch to Propane takes time to run a line underground and for the company to place a tank. Also, would have to find a heating contractor to convert the furnace, stove and hot water tank. Do we find an alternative source now or wait to the last minute? The cost to switch will cost in the thousands. What if switch and then shortly thereafter Orwell takes over and then what. Switch back at another expense? Are we going to pay them \$700 or \$800 to run a line and then hire the heating contractor to come back out and switch everything again? I think PUCO needs to delay this ultimatum to find another alternative energy source until the summer. We need more time to investigate and allow Orwell the time to takeover. I am affected by your current conflict with ORNG (Mr. Osborne). To switch over from Propane to gas I had to pay \$350 to have my Furnace, Dryer and Stove converted and because my hot water tank could not be converted I had to purchase a new one at \$900 plus install for adapt to gas. My family and I reside at 15184 Ravenna Rd. Burton, OH, in Geauga County. Our home is supplied with natural gas by the Ohio Rural Natural Gas Co-op ("ORNG"). We have been advised that the PUCO has issued an order forcing ORNG to cease operations as of March 1<sup>st</sup> of this year to Geauga County and elsewhere in the State of Ohio. We wish to ask the PUCO for a temporary 45 day stay of this order due to a number of hardships that the order creates for my family as well as other for ORNG members. I will attempt to enumerate the hardships and issues below:

- 1. I contacted Amy at ORNG and asked for their assistance in finding an alternative source of energy and they advised that they were unable to assist us. She advised me that she would have Richard Osborne contact me but he has yet to return my call.
- 2. My wife, Lee Rainer, spoke with Giselle Iafelice at Orwell Natural Gas ("ONG"), at the recommendation of the PUCO, and ONG advised that the closest gas line to our property is 1,000 feet away. They advised that the cost to connect our property will close to \$20,000.
- 3. Our home was previously an all-electric home and we heated it with a heat pump. In 2016, we added a large addition to the house. As part of the addition we added gas heat, a gas hot water heater, and a gas fireplace. We then had the electric heat pump removed and replaced the furnace in the main part of the house with a new gas furnace. We paid ORNG a tap in and membership fee of \$3,600. It cost an additional \$4,883.81 to have the gas line brought to our residence. The cost of the two gas furnaces and installation was in excess of \$15,500. We have incurred an additional expenses of nearly \$3,000 for interior gas line plumbing and a gas hot water heater. A gas fireplace cost an additional \$1,200. In total we have spent well in excess of \$25,000 on gas related equipment.
- 4. Besides my wife and myself we have three small children, ages eight, six, and 19 months, and several animals. The thought of being unable to heat our home is untenable.
- 5. Switching to an alternative energy source creates a huge financial burden since it is very costly and may require long-term commitments with alternative energy suppliers.
- 6. As of this date, ORNG has not been able to remedy the long list of PUCO violation nor have they been successful in selling their company, which they claim to be pursuing. Though I don't know how they can sell a non-profit organization.
- 7. There are only two weeks until the PUCO order goes into effect and ORNG is forced to discontinue service to our family. Even with 30-days notification there is not enough time for anyone to switch to an alternative energy source.
- 8. It has long been recognized in Ohio and by the PUCO that the end of winter is April 15<sup>th</sup> and programs are in place to prevent the cessation of gas service from mid-October through mid-April. It is disconcerting that the PUCO would force ORNG to cease operations to families some 45 days prior to April 15<sup>th</sup>, particularly when there are no other sources of energy readily available.
- 9. Although the numerous violations against ORNG have been well documented by the PUCO, and to the extent that the PUCO must act to preserve public safety, I can find no record of ORNG violations that have occurred within Geauga County.

For these and other reasons, we pray the PUCO reconsiders its order to force ORNG to cease operations and stay that order until April 15, 2017. This stay request is reasonable, there is no evidence of risk of adverse harm to persons or property within Geauga County during the period of the stay, and the stay will then allow the effected families the summer for ORNG to be replaced or to find another source of energy.
