Note: A residential customer's local exchange service consists of three tariffed components: a network access line, a central office termination and usage. However, these three tariffed components are displayed as two charges on the customer's bill, a Line Charge and a Usage Charge. For example, for flat rate local service, using rates in effect prior to 3-1-2017; the rate is calculated and shown on the bill as follows:

Customer bills display a Line Charge of \$14.20, which is a combination of the network access line rate (\$11.90) and the central office termination rate (\$2.30), as well as an Unlimited Residence Service (flat rate usage) rate of \$7.55. As a result of the 3-1-2017 rate increase, the tariffed rate for a flat rate residential network access line will increase by \$1.25, going from \$11.90 to \$13.15. The Line Charge rate displayed on the bill, which includes the network access line rate, will reflect this increase and will change from \$14.20 to \$15.45. So, for flat rate local service, using rates in effect subsequent to 3-1-2017, the rate will be calculated and shown on the bill as follows:
